**74. Motion**

That Council has no confidence in the Mayor and calls on him to resign forthwith."

Councillor David Renard moved and Councillor Mike Bawden seconded that the Motion be amended to read:

"That Council notes the:

(1) Constitution adopted by this Council on 17<sup>th</sup> May 2013 (Council Minute 8, 2013/14 refers).

(2) Corporate Governance Review Working Group Minute 28 (2012/13), which says; "The Working Group noted concerns expressed regarding recent notices of Motion which appeared to pre-empt decisions to be taken in the near future by the Council."

(3) Basic principle of justice that a person who is accused should have a right to know and question the accusations brought against him or her.

This Council resolves to:

(1) Continue to uphold its Constitution.

(2) Maintain the traditional British legal principle that a person is innocent until proven guilty.

(3) Refrain from making premature judgements about any Member of this Council that may prejudice an on-going investigation by the Standards Committee."

The amendment was put to the vote and declared carried becoming the Substantive Motion.
