23 Staffing levels are a matter for managers to address. Where we cannot respond to a missed collection we make every effort to return quickly and we prioritise collecting refuse to ensure it does not create a health hazard. The Council conducts over 30,000 collections per day and typically receives around 50 to 70 reports of misses – equating to less than two misses per thousand. There are plans being developed to improve the way missed collections are handled, using in-cab systems in the vehicles which will be linked to the new citizen portal website, this will speed up the process of missed collections being communicated to crews and will allow them to confirm when they have completed the outstanding work
